The PPF network reserves the right to deny, cancel, or refuse anyone the right to use our network without cause. By signing up with the PPF network you understand that there are no refunds on license fees or escrow account deposits. When using the PPF network system you must work the leads using the "LeadApp" system which we provide and use to track the progress of leads and loan deals in the works. You must keep notes on the leads you call and accurate details on all loan deals you are working using the LeadApp system. You must notify us the day you have a deal close this is verified by customer communications and follow up. PPF monitors your companies marketing efforts with the included LeadApp system. All leads are in your own LeadApp system account and we track all phases of your prospecting. If at anytime we see any abuse or members trying to cheat the PPF system by "ghosting" or hiding loan deals your account will be suspended and any funds in escrow and your yearly fee forfeited.

All services and payments sent to PPF are guaranteed by the member. If for any reason your payment is rejected, declined or reversed you give PPF permission to draft any alternative accounts and/or to use any information you have provided us to collect on the debt. You will be personally responsible for any collection, bank, or attorney fees that PPF incurs due to defaulted payments or balances owed. PPF reports to the primary account holders credit report and collection agencies if payments owed are 30 days past due.

Escrow Payment Method: The escrow payment method in short is where you deposit money in to your PPF account to secure leads and service. Upon closing a loan deal the funds are pulled from this account. All new members must start an escrow account of at least \$1000.00 ( 2 guaranteed loan deals). After the initial escrow is used you will be billed directly by email, mail or fax.

Cancellation: At anytime PPF reserves to cancel your account if you violate any of our terms written, expressed or implied. At anytime you may cancel your account with PPF however, all escrow funds and yearly dues are non-refundable.

Down Time: The PPF is on a secure server network using state of the art facilities, hardware and software. PPF is not responsible for any downtime, data loss, or deal losses that may occur from acts of god or other technical issues. We do back up data on a daily basis and have battery backed up servers and power generators in place incase of power loss.

This thwarts any credit card fraud and keeps our service prices lower. To make a payment and to activate your PPF user account and start getting leads from PPF to work, please include a check copy made out as if you were mailing it made payable to PayPerFunding.com, and fax the copy of the check with this signed agreement.
